Ravalomanana passport appeal fails

Bloemfontein - South Africa's highest court has rejected a final appeal by ousted Madagascan president Marc Ravalomanana to have his passport returned, it said in a statement.

"The Constitutional Court has considered the application for leave to appeal. It has concluded that it is not in the interest of justice to hear the matter at this stage," the court said in an order issued on Monday.

"The application for leave to appeal is dismissed."

Ravalomanana's passport was confiscated in September by South African prosecutors. A High Court ruled he would only be allowed to leave the country when he is invited to attend regional meetings,
